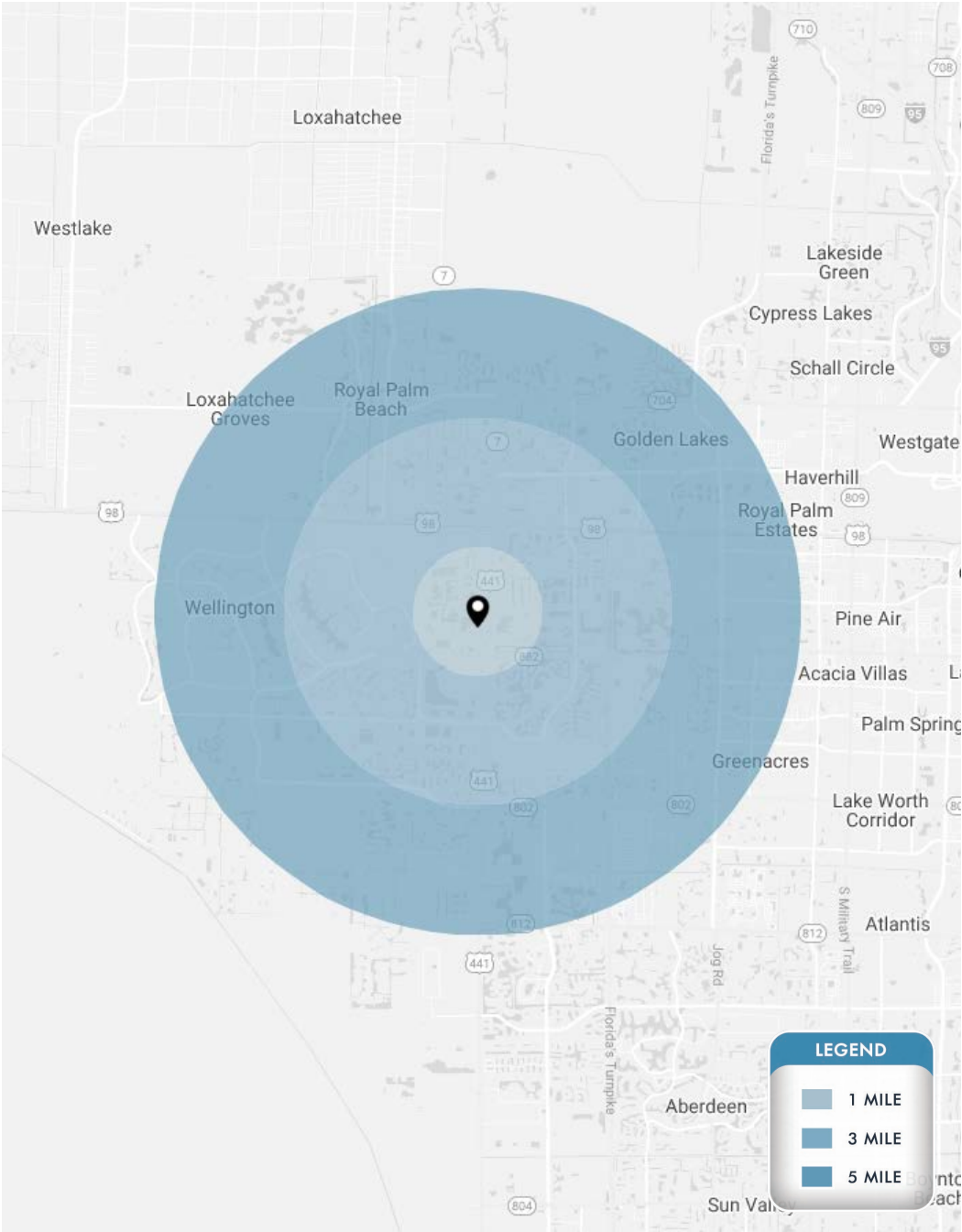

HIGHLIGHTS

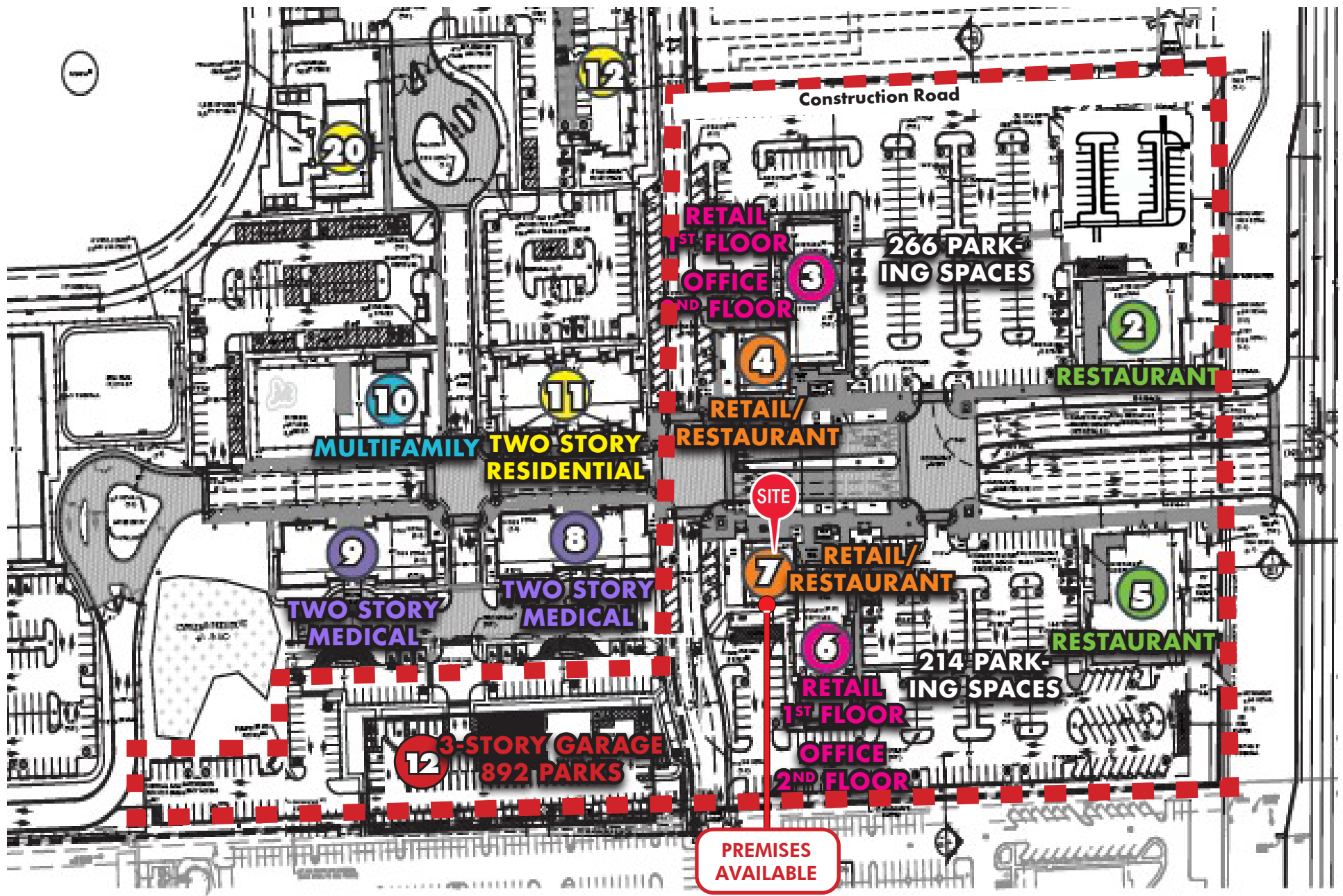
- New mixed-use project coming to Wellington on 64 acres just north of Forest Hill Boulevard and Highway 441/SR7
- 2 Restaurants: ±3,600 SF with ±675 SF patio available
- Retail: ±1,595 SF space available
- Located in the dominant retail market of The Mall at Wellington Green and adjacent to the Wellington Regional Medical Center with 233 beds and approximately 764 employees
- Servicing a trade area 300,000 people
- The main entrance is located on Highway 441/SR 7 with over 66,000 cars per day passing Lotis Wellington at his fully signalized intersection
- Uses include: restaurant (17,878 SF), inline restaurant/retail (28,405 SF), restaurant (7,200 SF; two 3,600 SF with patios), medical office (40,000 SF), professional office (12,892 SF), and luxury multifamily
- Total parking spaces in Phase 1: three story parking garage with 329 parking spaces and 546 surface parking spaces

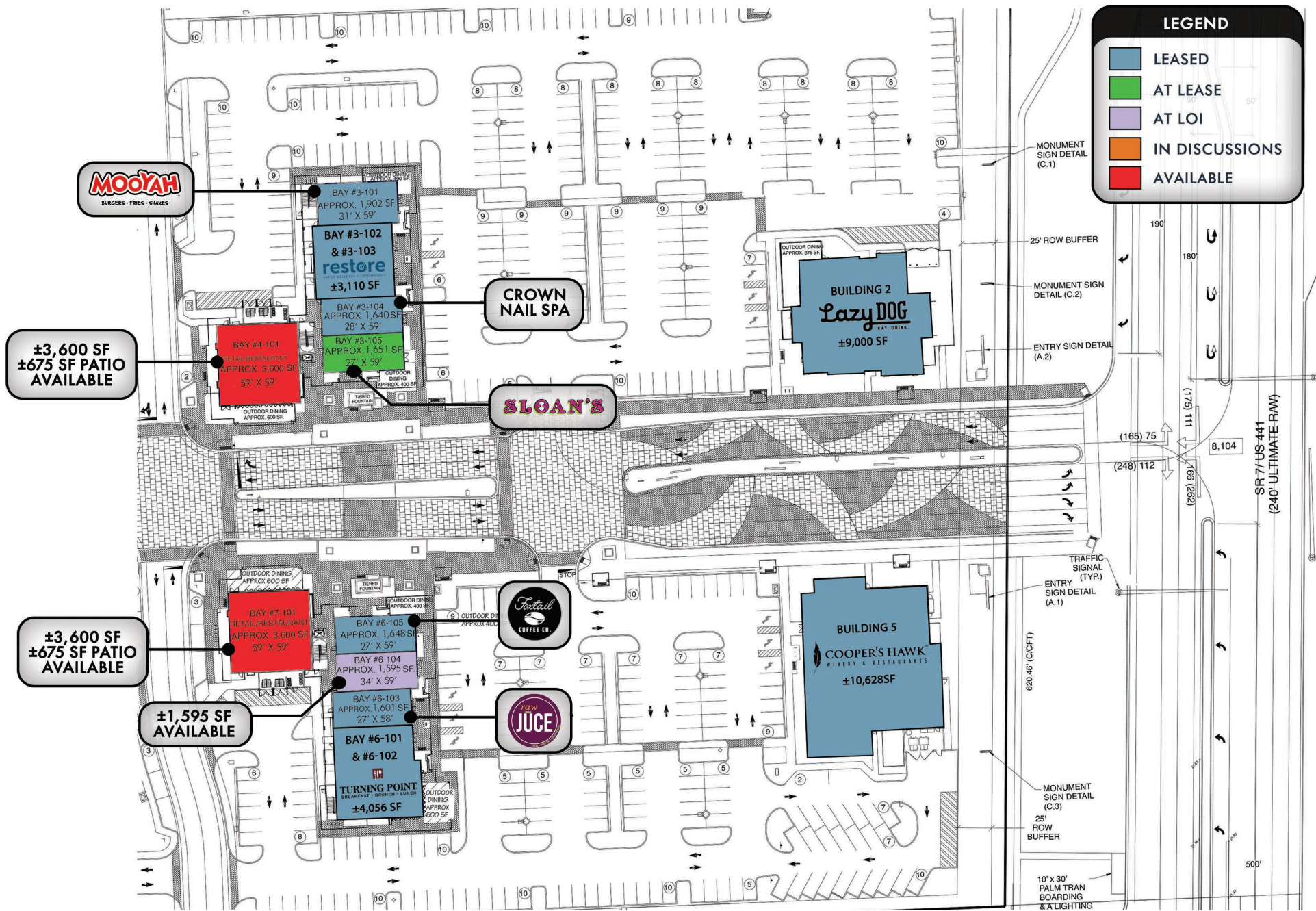
